Introduction

- In 1981, after 28 months of establishment of newregime of the Islamic Republic of Iran, the terrorist group of Mojahedin khalgh organization (MKO) began Is terrorist operations against the people and government of Iran.

-And one month after, Masoud Rajavi, the leader of the MKO, founded another group, National Council of Resistance of Iran (NCRI), to pretend that other groups and personalities had joined and supported him.

-At that time, Rajavi wanted to use the influence of the fired president, BaniSadr, and some parts of the democratic party of Iranian kurdistan and also a few other communist groups to achieve his goals.

-But BaniSadr and other groups that supported Rajavi then left the MKO and NCRI because of their un-democratic behaviour.

-In the last few years nothing has left from NCRI but a name to let the MKO continues its activities under its disguise.

-In Europe and the USA, where the terrorist nature of the MKO is well-known, the group is trying to follow its operations under the cover of the NCRI.

-This report includes hard evidence and documents to provide you with futher information about the stablishment,

members and leadership of the NCRI, and the abuses of the MKO from this title.

-It is our hope that accurate information about the illegal operations of the MKO under the disguise of NCRI will be of great help to stop their activities all over the world.

- Papers, documents, individuals and subjects, which are cited in this bulletin, are just a part of documents and material. These are quoted, as samples and if receivers of this bulletin require more information on any subject, please notify the title in order of documentation.
- There have been provisions undeniable proofs and documents, which are mostly collected from open sources and documents are photo typed. If there is a need for more Explanation on any object, it will be ready for representation.
- Parts written in blue usually at the end of pages, are prepared by providers of the bulletin and indicate conclusions, Intimations or facts that are proved by the documents represented.

One week after the announcement of founding National Council of Resistance (NCRI), their first action was hijacking.

Rajavi, the leader of MKO terrorist group, and his former ally in NCRI (Bani Sadr) are seen in the picture along with the hijackers. A month before that, MKO's penetrates exploded the office of Islamic Republic party with a bomb and killing more than 70 individual. Although unlike imagination of MKO's leader, this explosion did not result to overthrow Iranian government.
