

#### Brief on meeting places of NCRI in Iraq

- The first NCRI's meeting was held in a part of this compound and in a building named "Army Staff" of NLA in Iraq.

- This meeting was held in a compound 80 KM north Baghdad and close to the city of Khales.
- -MKO calls this compound "ASHRAF". It is the main and the most important headquarters of MKO's terrorists in Iraq.

The first NCRI meeting was held in Iraq on winter 1987, during the Iraq war against Iran.

Briefs on location of NCRI's meetings in Iraq from the beginning till


from 1988 to 1993 NCRI's meetings were held in bases *Called* "Saieed Mohsen" & "Jalalzadeh" in city of Baghdad.

These two bases are located in one of the main central avenues of Baghdad name Andolus

These two bases located adverse each other and are under full military and police protection by Iraq's security forces and MKO armed men.

On 1993, by request of Masoud Rajavi, leader of MKO, a new building *Called* "Baharestan" was built by Iraqi Government and handed over to MKO, in order to hold up NCRI's meetings.



#### Present location of NCRI`s Meetings in Baghdad

- This place (meeting hall ) is called Baharestan Hall by MKO'S terrorists leader.
- NCRI's meetings have been held in this place since 1993
- This place was built with an expense of 150,000 \$ by
  request of Rajavi and Saddam Hosein`s agreement.
  With ministry of Masonry's control it was built by FAW
  constructional company. ( related to Iraq's military
  industries )
- One of the reasons of this building's high expense is that it was ordered to be "without middle columns" for propaganda reasons and in order to make a proper area for photography and recording.
- Security of this position is provided by Iraq's Security
   Service called "Jahaz Almokhaberat AlAraghia"
- MKO armed forces are also cooperate in providing the security for this place.
- All the rooms of Hotel novhotel which is located at the west side of this building have been evacuated by Iraq's Security Forces, because they were impendence to The location.
- On December 1993, MKO's forces killed a Turkish government diplomat with sub machinegun in front of this building.

#### Massoud Rajavi's role in NCRI, NLA, and MKO








