Yves Bonnet's French lawyers condemned MKO's fake announcement

French lawyers of Yves Bonnet seriously condemned the group's misinformation on his court ruling and reproached MKO for distortion of the ruling.

Following the biting failure of Yves Bonnet, former Head of French Secret Service, in French appeal court in Paris, Rajavi's band set off for a disinformation campaign quoting fake words of Bonnet's French lawyers.


In the announcement allegedly related to 5 French lawyers published on MKO's websites in Persian, Yves Bonnet has won two courts against his plaintiffs during the 2 past years. In fact, Mr. Yves Bonnet absolutely lost his two courts in Paris where Rajavi's Band had

mobilized 600 people and attacked and bit critics.

He was sentenced to pay penalty and publish an apology letter in three French newspapers.

He was required by the court to mention in the letter of apology that his book:" Vevak at Ayatollahs service" was written under the orders of Mujahedin Khalq Organization. He also had to pay a 3000 – euro penalty.

Following the publication of the distorted announceregarding ment Bonnet's Court, plaintiffs of the court complained to french judiciary .Yves Bonnet's attorneys, to respond the court judge, denied the announcement published on MKO official websites and declared that they didn't compose or publish any announcement



regarding Yves Bonnet's court.

They seriously condemned MKO's obstinate act to distort the ruling of French judiciary.

The attorneys told that they hadn't been aware of the text of the announcement and admitted that the court ruling was based on Mr. Bonnet's failure.

Retired US Officer: No Country Willing to Shelter MKO Members

No country in the world is ready to shelter the anti-Iran terrorist Mojahedin-e Khalq Organization

(MKO) members and their only left option is a return to Iran, a retired US intelligence officer said.

"We have talked with several countries via the US State Department but no one is willing to accept them in his country, "Steve Hasty said, addressing the audience at the 'International Policy Institute'.

"And the only way left for them might be a return to

Iran," he added.

Hasty also warned about the MKO members' severe sexual misconducts,

abuse and deviations and cultic tendencies, and said they have committed many crimes against the Iranian and Iraqi nations and the people of these two countries hate them all.

The MKO, whose main stronghold is in Iraq, is blacklisted by much of the

international community, including the United States. Before an overture by the EU, the MKO was on the European Union's list of terrorist organizations subject to an EU-wide assets freeze. Yet, the MKO puppet leader, Maryam Rajavi, who has residency in France, regularly visited Brussels and despite the ban enjoyed full freedom in Europe.

The MKO is behind a slew of assassinations and bombings inside Iran, a number of EU parliamentarians said in a recent letter in which



helping Saddam Hussein in the Iraqi imposed war on Iran (1980-1988).

Many of the MKO members abandoned the terrorist organization while most of those still remaining in the camp are said to be willing to quit but are under pressure and torture not to do so.

Why Doesn't MKO Let Members go?

More than seven years after the fall of Iraqi dictator Saddam Hussein, MKO leaders still force members to stay in the group. They treat their rank and file as hostages who are not even

allowed to contact or visittheir picketing families at Ashraf gates. Besides, the hostages are always at risk of an other bloodshed since it is clear that Iraqi government doesn't want them in its territory.

The bloody clashes at camp Ashraf in June, 2009 and April, 2011 do not promote MKO leaders to think of a solution for members transferring instead they exploit the killing of their forces as fuel for their propaganda Despite machine. threatened situation of Ashraf residents, the camp leaders do not let them choose for their future in the current critical condition of Camp Ashraf.

Although the killing of 32 Ashraf residents is controversial and both sides of the clashes accuse each other for the massacre, one thing is clear and that's the danger that Ashraf residents are exposed to either by the side of Iraqi security forces or by the MKO leaders, Ashraf residents are the main victims of such crisis. What have MKO leaders done to prevent other incidents like the previous ones?

Absolutely nothing! In the early May, the United States presented a plan to relocate the Mujahedin Khalq in another Iraqi region far from Iranian border. A senior State Department official said the plan was aimed at preventing more violence at Camp Ashraf, according to Reuters.[1] although the solution offered by US officials seemed operational for short-term, MKO's Paris spokesman said the plan would lead "to a concentration camp" and "the ultimate result will be a new Auschwite".[2]

Mohaddesin's fallacious argument to prolong the group's stay at camp Ashraf was confirmed by the group's Scottish advocate in



European parliament, Struan Stevenson. The EU conservative MP said relocating the MEK was "not an acceptable alternative", Roy Gutman of McClatchy Newspaper reported.[3]

On May11, Struan Stevenson apparently proposed a plan to European Parliament for the removal of Camp Ashraf residents from Iraq. His plan contains 5 conditions to be met. [4] Mr. Stevenson proposal is unilateral because the rights of Iragi nation as the owner of its territory are totally ignored in it. The entire plan implies that Iraqi government is offensive and Mujahedin are offended. However, there is still ambiguity about the truth of what exactly happened on April 8th2011 at Camp Ashraf. He never notices that MKO leaders do not allow the residents to choose whether to leave or to stay. They have to stay.

from (the camp) Ashraf (in Iraq), he/she will be killed or executed," Abdollatif Chahardari said.

He reiterated that the ringleaders of the MKO also prevent the members who are residing in Camp Ashraf from taking refuge in other countries, saying, "Ashraf is the only place you have."

Also in March, another defected member of the MKO revealed that the female members of the group have been living under captivity for more than 25 years and are not even allowed to appear in public places alone. "It can be firmly said that 95% of the women in Ashraf Camp (the terrorist group's resort in Iraq) have not even been allowed to step in Iraq's public and recreational places alone all throughout the last 25 years," the defected member said.

A May 2005 Human Rights Watch report accused the MKO of running prison camps in Iraq and committing human rights violations.

Iraqi lawmakers slam US intervention

Reacting to latest US government proposal to relocate the terrorist organization, MKO or Mujahedin-e Khalq Organization, to another place within Iraq's territory, Iraqi lawmakers have called it another US intervention in country's internal affairs.

The US government has proposed moving the camp of the MKO, known as Camp Ashraf, which is located in the Province of Diyala to another place inside the country.

The proposal comes only few days after the Iraqi government set a deadline of for MKO members to leave the country.



The Iraqi lawmakers from Sadr Movement have condemned US intervention in their country's internal affairs. They believe the US is trying to keep these terrorists in Iraq to use them against neighbouring countries.

The spokesperson of the Iraqi government said the Iraqi government cannot accept to be under such burden and urged the

International community to help the Iraqi government in the process of MKO expulsion from Iraq.

The members of the Iraqi national Alliance have also stressed on the importance of bringing an end to such interference.

The members in the State of Law Coalition said such behavior will have negative effect on the political process in Iraq and these actions are in clear contradiction to US claims of trying to keep the region peaceful.

Abdollatif Shadvari is a former member of MKO who has recently escaped the cult. He is asked by Golnaz Esfandiari of Radio Free Europe why MKO wants to keep people in Camp Ashraf and why they don't let those who don't want to be there go." it's obvious," he answered "If people [leave Ashraf], the organization will fall apart, there won't be any Mujahedin-e-Khalq Organization anymore."[6]

In her speech among a number of her European sponsors like Alejo Vidal Quadras and Struan Stevenson, Maryam Rajavi threatened the world over a massacre at camp Ashraf."I warn that any forcible relocation is a prelude to massacre the residents," she said. [For those who are informed of MKO cult-like nature, it is clear that who will perform the massacre. You may remember the vague record of killing of 35 people on April 8 or the self-immolations on June 2003, following the arrest of Maryam Rajavi by French Police.

MKO's firm stance against relocation and Stevenson's unilateral, time killing plan are signs of Rajavi's strong will to maintain the cult's only ideological container since the removal of Ashraf signifies the removal of the organization that has worked to recruit and keep thousands of people behind its bars in their isolated world...

paying the cost of Rajavi's treasonous acts. Nejat Society calls for the shutdown of Camp Ashraf and MKO expulsion from Iraq because:

- 1. Breaking the bars of the cult in Camp Ashraf or any other new camp can lead our children to decide for their own fate freely.
- 2. It prevents the cult from deceiving and then recruiting new forces that causes the collapse of more families.
- 3. Consequently following

the closure of Camp Ashraf, and separation of more than 90 percent of dissident members, the cult leader will face numerous problems and ultimately a cul-de-sac.

Nejat Society believes that there is no need for relocation of Camp Ashraf. A look at recent cases indicates that so far about 1000 defectors of MKO could manage to live a free life in European countries as well as Iran and no judicial obstacle was on their way. If

the cult leaders are honest in their words, they should allow

the members to decide whether to leave the group or stay in the cult, with their own free will not under the atmosphere of fear and pressure. Then they will see that there will be no more residents to move to another Iraqi area.

The US and EU countries that support MKO Cult looking for a decision to make for future of the cult, can make their mind within the deadline Iraqi government has assigned for MKO expulsion. The American plan is actually a solution to preserve the cult of Rajavi that Nejat families do not approve.

According to the Human Rights Watch report, the outlawed group puts defectors under torture and jail terms.

The group, founded in the 1960s, blended elements of Islamism and Stalinism and participated in the overthrow of the US-backed Shah of Iran in 1979. Ahead of the revolution, the MKO conducted attacks and assassinations against both Iranian and Western targets.

The group started assassination of the

citizens and officials after the revolution in a bid to take control of the newly established Islamic Republic. It killed several of Iran's new leaders in the early years after the revolution, including the then President, Mohammad Ali Rajayee, Prime Minister, Mohammad Javad Bahonar and the Judiciary Chief, Mohammad Hossein Beheshti who were killed in bomb attacks by MKO members in 1981.

The group fled to Iraq in 1986, where it was protected by Saddam Hussein and where it

helped the Iraqi dictator suppress Shiite and Kurd uprisings in the country.
